Vendor applications are considered by the Farmers Market Collective Management, which consists of the North Coast Food Web Board of Directors. Based on the Product Definitions and Guidelines section of the Market Handbook, and on considerations of product mix in the Market, they either accept an application as is, deny it or accept it with conditions. Appeals to their decisions can be made to the River People Farmers Market Committee, in writing and within 10 business days of the Support Staff's decision, and sent to: River People Farmers Market Committee; 577 18th St., Astoria, Oregon 97103. The Committee shall render a final decision within 10 business days of the vendor's written appeal.
